ORDINANCE NO. 648

AN ORDINANCE OF THE TOWNSHIP OF LOWER PROVIDENCE, MONTGOMERY COUNTY, PENNSYLVANIA, AMENDING PART 3, STORMWATER AND EROSION CONTROL, SECTION 123-91 AND REPEALING SECTIONS 123-92 THROUGH 123-127 OF THE CODE OF THE TOWNSHIP OF LOWER PROVIDENCE

WHEREAS, the Board of Supervisors of Lower Providence Township has enacted Chapter 129, Stormwater Management, of the Code of the Township of Lower Providence; and

WHEREAS, the enactment of Chapter 129, Stormwater Management repeals and replaces Sections 123-92 through 123-127 of Chapter 123, Subdivision and Land Development of the Code of the Township of Lower Providence.

NOW, THEREFORE, it is hereby **ENACTED and ORDAINED** by the Board of Supervisors of Lower Providence Township as follows:

SECTION I.

Part 3, Stormwater and Erosion Control, Section 123-91 "Title", of Chapter 123, Subdivision and Development of Land, of the Code of the Township of Lower Providence, is hereby amended to read as follows:

§123-91 Compliance with Chapter 129 Stormwater Management.

All land developments and subdivisions within Lower Providence Township must comply with the requirements of Chapter 129, Stormwater Management of the Code of the Township of Lower Providence.

SECTION II.

Part 3, Stormwater and Erosion Control, Sections 123-92 through 123-127, of Chapter 123, Subdivision and Development of Land, of the Code of the Township of Lower Providence are hereby repealed in their entirety and replaced by reference to Chapter 129, Stormwater Management of the Code of the Township of Lower Providence.

SECTION III. Repealer

All ordinances or parts of ordinances which are inconsistent herewith are hereby repealed.

SECTION IV. Severability

If any section, paragraph, subsection, clause or provision of this Ordinance shall be declared invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of this Ordinance as a whole or any part thereof other than that portion specifically declared invalid.

SECTION V. Effective Date

This Ordinance shall become effective five (5) days after final enactment.
