**AN ORDINANCE OF LOWER PROVIDENCE TOWNSHIP,  
MONTGOMERY COUNTY, PENNSYLVANIA, AMENDING CHAPTER  
138, ARTICLE III, PARKING REGULATIONS, SECTION 138-25  
PARKING TIME LIMITED ON CERTAIN ROADS**

*WHEREAS*, the Township has established parking limits upon certain roads within the Township; and

*WHEREAS*, the Township desires to amend a parking time limitation from 6:30 a.m. to 6:30 p.m. on the west side of Clearfield Avenue in the Township from Ridge Pike to Oakdale Avenue.

**NOW, THEREFORE**, be it is hereby **ORDAINED AND ENACTED** by the Lower Providence Township Board of Supervisors as follows:

**ARTICLE I.**

Chapter 138, Article III, Section 138-25, "Parking time limited" is hereby amended as follows:

**§138-25. Parking time limited.**

No person shall park a vehicle or allow the same to remain parked upon any of the highways or parts of highways described below between the hours specified, for longer than the time indicated below:

Clearfield Avenue	West side from 6:30 a.m. to 6:30 p.m.	<del>From Ridge Pike south</del> for 30 feet [From Ridge Pike to Oakdale Avenue]

All ordinances or parts of ordinances which are inconsistent herewith are hereby repealed.

**ARTICLE III.      Severability**




**ARTICLE IV.      Effective Date**


This Ordinance shall become effective five (5) days after final enactment.


