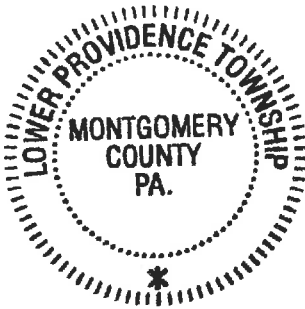


**LOWER PROVIDENCE TOWNSHIP

WHEREAS, House Bill 1590 was signed into law by Gov. Corbett on October 22, 2014 and, among other requirements, requires that all tax collectors must appoint a deputy tax collector; and

WHEREAS, the deputy tax collector would collect and settle taxes during any incapacitation of the elected tax collector, with the tax collector being responsible for any actions by his/her deputy.

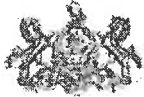
