

Board of Supervisors' Actions – November 21, 2019 Business Meeting

LOWER PROVIDENCE TOWNSHIP – The Lower Providence Township Board of Supervisors took the following actions at the November 21st business meeting:

Approvals and Authorizations

- Approved the Consent Agenda, including:
 - Minutes of the November 7, 2019 Board of Supervisors business meeting
 - Payment of bills in the amount of \$380,896.96
 - Release of escrow payments
 - Crawford Estates release #3 in the amount of \$40,015.00
 - Courts at Brynwood Phase II release #1 in the amount of \$119,019.00
- Approved a request for waiver of fence standards to permit fencing through a storm sewer easement and solid-style fencing in the front yard at 1008 Arcola Glen Drive.
- Approved a request from PJM Interconnection for "No Parking" designation on portions of Van Buren and Jefferson avenues for security purposes and authorized the solicitor to prepare an ordinance amendment identifying the no parking areas.
- Authorized the advertisement of a proposed residential zoning update ordinance to be considered at the December 19, 2019 meeting.
- Authorized the solicitor to prepare and advertise an ordinance rescinding Ordinance No. 660 pertaining to the Village Housing Overlay in the R-2 zoning district.
- Authorized the advertisement of the appointment of BBD as the Township auditor for the year 2019 with the appointment to take place at the Board's Reorganization Meeting on January 6, 2020.

Resolutions

• Approved <u>Resolution 2019-33</u> approving the preliminary/final land development plan for IROY sports facility, 3444 Germantown Pike including a condition to install an electric vehicle charging station.

Discussions

• Discussed the feasibility of an electric vehicle charging station at the Township complex; no action was taken.

Proclamation

• Read a proclamation recognizing the significance of the John James Audubon Center at Mill Grove.
