**LOWER PROVIDENCE TOWNSHIP** – The Lower Providence Township Board of Supervisors took the following actions at the July 16<sup>th</sup> business meeting:

## Approvals

- Approved the consent agenda including:
  - <u>Minutes of the June 18<sup>th</sup> meeting</u> of the Board of Supervisors
  - Treasurer's Report
  - Payment of bills in the amount of \$1,014,540.31
- Authorized the advertisement of an ordinance restricting parking along Kriebel Mill Road, from the cul-de-sac to the Worcester Township line, between 7:00 a.m. to 3:00 p.m., Monday through Friday.
- Approved the following appointments to the Township Environmental Advisory Council: Leah Baird, Patrick Duffy, Joseph Lulis, Erin McCool and John Zollers.
- Tabled the request of the homeowner of 628 Mourning Dove Road for a waiver of fence requirements to allow the installation of a solid-style, six-foot fence partially in the front yard.

### Resolutions

- Approved <u>Resolution No. 2020-13</u> approving the right-of-way acquisition process for the Park Avenue-Eagleville Road-Crawford Road intersection improvement process.
- Approved <u>Resolution No. 2020-14</u> accepting the proposal from Gannett Fleming for engineering services to design the relocation of the sanitary sewer lines along and under Park Avenue and Crawford Road as part of the Park Avenue-Eagleville Road-Crawford Road intersection re-alignment project.
