Call to Order: Chairman Sorgini called the meeting to order at 7:40 p.m.

Pledge of Allegiance

Roll Call:

- a. The following members were in attendance: Chairman Sorgini, Supervisors Eckman, Duffy, MacFarland, Sorgini, and Zimmerman.
- b. Chairman's Comments: Chairman Sorgini announced that prior to the meeting an executive session was held discussing legal and personnel matters. He also announced that an executive session was held on December 30, 2015.

- 1) Appointment of Temporary Chairman Temporary Secretary
 - A) Chairman Sorgini appointed Peter MacFarland as temporary chairman and Richard Gestrich as temporary secretary.
- 2) Election of Chairman
 - A) **MOTION:** Supervisor Zimmerman made a motion to appoint Jason Sorgini as Chairman for 2016. Supervisor Eckman seconded the motion. The motion *passed* 5-0.
- 3) Election of Vice-Chairman
 - A) **MOTION:** Supervisor Zimmerman made a motion to appoint Colleen Eckman as Vice-Chairman for 2016. Supervisor MacFarland seconded the motion. The motion *passed* 5-0.

 - B) A Resolution Designating Depositories for Township Funds.
 - i) **MOTION:** Supervisor MacFarland made a motion to adopt the resolution designating depositories for Township funds. Supervisor Eckman seconded the motion. The motion *passed* 5-0.
 - C) A Resolution to Establish the Amount of the Treasurer's Bond at \$600,000 and \$100,000 for Secretary.
 - i) **MOTION:** Supervisor Zimmerman made a motion to adopt the resolution to establish the amount of the Treasurer's Bond at \$600,000 and \$100,000 for Secretary. Supervisor Eckman seconded the motion. The motion *passed* 5-0.
 - D) A Resolution Establishing the Police Officers Contributions to the Police Pension Plan for the Year 2015.
 - i) **MOTION:** Supervisor Eckman made a motion to approve the resolution establishing the Police Officers Contributions to the Police Pension Plan for 2016 at 2%. Supervisor Duffy seconded the motion. The Motion *passed 5-0*.

- E) <u>A Resolution Establishing Member Contributions to the Employees Pension Fund for the Year</u> 2015.
 - i) **MOTION:** Supervisor Duffy made a motion to approve the resolution establishing member contributions to the Employee Pension Fund for 2016 at .75%. Supervisor Zimmerman seconded the motion. The motion *passed* 5-0.
- F) <u>A Resolution Appointing the Certified Public Accounting Firm of Maillie LLP to Serve as</u> Auditors to Audit the Accounts of Lower Providence Township for Fiscal Year 2015.
 - i) **MOTION:** Supervisor Zimmerman made a motion to approve the resolution. Supervisor Eckman seconded the motion. The motion *passed* 5-0.
- G) Certification of Delegates and Voting Delegate to PSATS Annual State Convention.
 - i) **MOTION:** Chairman Sorgini made a motion to appoint Colleen Eckman as the PSATS delegate for 2016 with Supervisors MacFarland, Duffy and Zimmerman attending the convention. Supervisor Duffy seconded the motion. The motion *passed* 5-0.
- H) A Resolution setting the Township Manager's salary
 - i) Chairman Sorgini explained that they had looked at the compensation rate for the Township Manager, comparing it to similar townships in the area. Finding it much lower than comparable positions in surrounding townships. He put forth a resolution raising the compensation to \$122,000 per year.
 - ii) **MOTION:** Chairman Sorgini made a motion to set the Township Manager's salary at \$122,000 per year. Supervisor MacFarland seconded the motion.
 - (1) Supervisor Eckman stated that while dollar amount was relatively small, she felt this matter should have been addressed during the budget process.

The motion *passed* 4-1 with Supervisor Eckman opposing.

25) New Business

A) Update on Sunnyside Park

- i) Mr. Mrozinski gave an update on the Sunnyside Mobile Home Park. He outlined the ongoing concerns of the property, which is owned by UMH Properties, Inc. He stated that Montgomery County was brought in to investigate potential health concerns and have been diligent in investigating. Mr. Mrozinski said that the Township met with UMH Properties and they committed to bringing the property into compliance but no movement has been seen toward that goal. The Township will continue to put pressure on the property owners to bring them into compliance.
- ii) Mr. Mrozinski discussed the most recent issues involving demolition of trailers and the property owner's lack of property permitting. He noted which citations and notices of violations had been issued to the property owner. Mr. Mrozinski stated he believes they have UMH's attention and they hope to have the issues at both 38 and 44 Ivy resolved this week.
- iii) Supervisor Eckman noted that the Township staff has put in a considerable amount of time in dealing with this property. She asked Mr. Mrozinski if he could give an estimate of the manhours spent on these issues. Mr. Mrozinski said that approximately 20-30 hours has been spent on issues at Sunnyside. He noted that most of that time was his but that both inspectors have also spent time at the site. Supervisor Eckman thanked the department for their efforts and diligence.
- iv) Chairman Sorgini also thanked the department and wanted the residents of Sunnyside Mobile Home Park to know that the Township has heard their concerns. He noted that both he and Supervisor Duffy were at the site last week and the Township will continue to persist in this matter.

26) Courtesy of the Floor:

- A) Tom Borai, Brenda Lane, asked what the Township Manager's salary was in 2015. Chairman Sorgini stated that it was \$116,000.
- B) Supervisor Duffy thanked Mr. Borai for his service to the Township's Zoning Hearing Board.

27) Announcements

A) Supervisor Sorgini announced that the swearing-in ceremony for Stanley M. Turtle as Chief of Police will be held on Tuesday, January 5 at 7 p.m. and invited residents to attend.

28) Adjournment:

A) **MOTION:** Supervisor Zimmerman made a motion to adjourn the meeting. Supervisor Duffy seconded the motion. The motion *passed 5-0*. The meeting adjourned at 8:10 p.m.
