

**LOWER PROVIDENCE TOWNSHIP
BOARD OF SUPERVISORS BUSINESS MEETING
March 31, 2021**

Call to Order: Chairman MacFarland called the virtual meeting to order at 7:00 p.m.

Pledge of Allegiance

Roll Call:

- a. The following members were in attendance: Chairman MacFarland, Vice-Chair Eckman, Supervisors Coless and Neights. Supervisor Sorgini was absent.
- b. Also in attendance were: John Rice, Township Solicitor; Don Delamater, Township Manager; Bill Roth, Special Projects and Technology, Tim Woodrow, Township Engineer and Michael Jackson, Chief of Police.
- c. Chairman MacFarland announced that an executive session was held on March 18th and prior to tonight meeting, to discuss legal and personnel matters. A moment of silence was held for the passing of Public Works Director John Primus and former Township supervisor Thomas Borai. Pages will be set aside in the minutes for both.

1) Consent Agenda

- A) **MOTION:** Supervisor Neights made a motion to approve the consent agenda items 1(a), and 1(b), including moving the minutes of March 4, 2021 into the record. Supervisor Coless seconded the motion. The motion *passed 4-0*.

- A) Request for waiver of fence standards at 1001 Doris Drive
 - i) Mr. Delamater reviewed the request of waiver of fence requirements at 1001 Doris Drive. The property owners, Satwinder Singh and Jaspreet Bhandall, were in attendance and reviewed the request.
 - ii) **MOTION:** Supervisor Colleen Eckman made a motion to approve the request for waiver. Supervisor Coless seconded the motion.
 - iii) There was no public comment.
 - iv) The motion *passed 4-0*.
- B) Request for waiver of fence standards at 900 Adams Avenue
 - i) Mr. Delamater reviewed the request of waiver of fence requirements at 900 Adams Avenue. The property manager, Nick DiCicco, was in attendance and reviewed the request.
 - ii) **MOTION:** Supervisor Neights made a motion to approve the request for waiver, with the conditions to use the new metal fence along Adams Avenue and extend that fence type between the other property rather than chain link fence and to allow the rear fence to be chain link. Chairman McFarland seconded the motion.

 - iv) The motion *passed 4-0*.
- C) Consideration of Lower Providence Fire Department's request for waiver of permit fees
 - i) Mr. Delamater reviewed the request of waiver of permit fees for roof replacement.

- ii) **MOTION:** Supervisor Neights made a motion to approve the request to waive the permit fees. Supervisor Eckman seconded the motion.

 - i) John Rice, Township Solicitor reviewed the Resolution 2021-11
 - ii) **MOTION:** Supervisor Neights made a motion to approve the Resolution 2021-11. Supervisor Eckman seconded the motion.
 - iii) There were no public comments.
 - iv) The motion passed 4-0.
