

**LOWER PROVIDENCE TOWNSHIP  
BOARD OF SUPERVISORS BUSINESS MEETING  
September 8, 2021**

**Call to Order:** Chairman MacFarland called the meeting to order at 7:10 p.m.

**Pledge of Allegiance**

*Due to technical difficulties with the audio for remote meeting attendees, the meeting was suspended. The meeting resumed at 7:35 p.m.*

**Roll Call:**

- a. The following members were in attendance: Chairman MacFarland, Vice-Chair Eckman, and Supervisors Coless and Sorgini. Supervisor Neights was in attendance remotely but did not have audio.
  - b. Also in attendance were John Rice, Township Solicitor; Gregg Schuster; Interim Township Manager; Bill Roth, Special Projects and Technology Director, and Chief Michael Jackson.
  - c. Chairman MacFarland announced that due to the continuing problems with the audio for those attempting to listen and participate remotely, many items on the agenda would be tabled until the September 22, 2021 meeting. He requested that Item 2c – Storm Update be added to the agenda with the understanding that it also would be tabled until September 22. He noted that Item 3c had been withdrawn from consideration by the applicant.
- A) **MOTION:** Supervisor Coless made a motion to add Item 2c – Storm Update to the agenda. Supervisor Sorgini seconded the motion.
- i) Supervisor Sorgini requested that the Township petition for assistance from the county, state and federal levels for the serious repairs needed on Germantown Pike and Evansburg Road.
  - ii) Chief Jackson said the county is working on a detour plan for Germantown Pike and said he would continue to work with them. He said the police department has increased enforcement on neighborhood roads seeing increased traffic.
  - iii) There was no public comment from those present.
  - iv) The motion *passed* 4-0.

**3) New Business**

A) Request for waiver of land development, 101 Hillside Avenue
