LOWER PROVIDENCE TOWNSHIP BOARD OF SUPERVISORS BUSINESS MEETING JANUARY 20, 2022

Call to Order: Chairman Neights called the hybrid live/virtual meeting to order at 7:00 p.m. **Pledge of Allegiance**

Roll Call:

- a. The following members were in attendance: Chairman Neights, Vice-Chair Coless, Supervisors Sorgini, MacFarland and Darby.

- B) American Rescue Plan Act Funds
 - i) E.J. Mentry gave a presentation on the American Rescue Plan Act Funds, including the history of the funding and some of the requirements for reporting and deadlines. He explained that the Final Rule was recently published by the Department of the Treasury and gives municipalities receiving less than ten million dollars the option to designate all of their funding for revenue replacement, which is the most flexible use of the funds. Since Lower Providence Township is receiving approximately two million, eight hundred thousand (\$2,800,000) dollars in American Rescue Plan funds, the recommendation will be to designate all of it for revenue replacement. Mr. Mentry recommended the Board discuss specific use of the funds at a future date in conjunction with the strategic planning discussions.
