Police Mission

The Lower Providence Township Police Department is a professional, progressive, community-oriented law enforcement organization committed to making the Township a great place to live, work and play. The department consists of thirty-one police officers, an executive assistant to the Chief of Police, a civilian police dispatcher, and a part-time evidence custodian.

Department Structure

Patrol Division - is the largest division and is responsible for the primary police services provided to the Township. The Patrol Division is composed of four platoons that are each supervised by a Sergeant. Patrol cars are equipped with Mobile Data Computers (MDC) which are computer terminals that provide officers instantaneous information on driver's license information, vehicle registration information, stolen vehicle information, wanted person information and confidential messaging between vehicles and the Police Dispatch Center. Officers can prepare accident reports and incident reports in their vehicles and transmit them electronically to the records management system server in the police station. All the patrol cars are equipped with Mobile Video and Audio Recorders (MVAR) that are utilized to digitally record vehicle stops, DUI enforcement, suspicious activity, and crime scenes. Within the Patrol Division, specialized units include officers assigned to the Traffic Safety Unit, with responsibility for coordinating traffic enforcement/safety, and the Bicycle Patrol Unit.









Detective Division - is responsible for the investigation of all criminal offenses that occur within the Township. Detective Sergeant Michael Higgins is responsible for this division and supervises Detective Scott Dreibelbis, Detective Michael Nastasi, and Detective Charles King who are all trained and experienced investigators.



In 2021, the Lower Providence Detectives investigated 577 criminal cases. These cases fluctuated in gravity from misdemeanor-level crimes to major felony crimes. Some of the more serious crimes that were investigated this year consisted of an Aggravated Assault at Warrior Field, Several Thefts from Motor Vehicles at B&M Auto Repair and Towing, Armed Suspect/Explosions on Cardin Place, and a Homicide on the Betzwood Trailhead.



LPPD detectives attended a seminar at the Lincoln Financial Field where they studied new trends in law enforcement partnerships during a multijurisdictional training with federal, state, and local agencies.





Administrative Sergeant / Traffic Safety Coordinator – is assigned to Sergeant Mark Stead. Sergeant Stead is responsible for traffic studies and traffic details, community policing and special events, Youth Aid Panel, roll call training, and several other administrative duties. Sergeant Stead is well known throughout our community and schools and always puts the community's well-being at the very top of his priority list.



Civilian Employees – are responsible for monitoring the police radio, accepting incoming emergency and non-emergency phone calls, case folder preparation, evidence maintenance, fingerprinting, accreditation, grant-writing, social media accounts, and numerous other administrative duties. Montgomery County SWAT Central Region Team (MSWAT-CR) – The Lower Providence Township Police Department is an active member of the Montgomery County SWAT Central Region Team. The MSWAT-CR team is a multi-jurisdictional, highly trained and equipped group of officers that respond to high-risk situations involving armed individuals, barricaded individuals and hostage situations. The team is available for response 24/7, 365 days a year and train rigorously on a monthly basis to keep their skill level sharp. Lower Providence Police have two officers assigned to the team, Corporal Robert Heim (Team Leader) and Officer Ryan Gill (Entry Element Team Member).









The Montgomery County Special Weapons and Tactics Central Region Team (MSWAT-CR) participated in a helicopter operation training along with the Philadelphia Police Department in King of Prussia during the month of October.

Bicycle Patrol - Eight members of the Lower Providence Township Police Department have been certified by the International Police Mountain Bike Association (IPMBA) for police bicycle patrol. The department currently utilizes police patrol bicycles at special events, shopping centers, apartment complexes and neighborhood patrols. Officers complete specialized training regularly but are required to complete training at least once every three years.



Accident Reconstruction – Two members of the Lower Providence Township Police Department, Sergeant Ryan Singleton and Officer Timothy Arthur, are certified accident reconstructionist. Officer Arthur is certified as an Expert Reconstructionist. The reconstructionist is in charge of determining the causation of all serious and fatal automobile accidents. The Lower Providence Township Police Department investigated one fatal accident in 2021 where both Sergeant Singleton and Officer Arthur assisted in the reconstruction.










Motor Carrier Safety Assistance Program (MCSAP) Certified Officer - Throughout Pennsylvania, more than 700 specially trained state and local officers inspect commercial vehicles and their drivers for compliance with state and federal motor carrier safety regulations. Inspections are conducted along all roadways within the township. The goal of MCSAP is to reduce commercial motor-vehicle involved crashes, fatalities, and injuries through consistent, uniform, and effective commercial motor-vehicle programs. The department has one MCSAP certified police officer, Sergeant Ryan Singleton, who is required to complete 70 commercial vehicle stops a year to maintain his certification.







DUI Enforcement - The Lower Providence Township Police Department is a member of the Valley Forge Area DUI Task Force which is comprised of several area police departments that combine their efforts and resources in addressing the issue of Driving Under the Influence of Alcohol and Controlled Substances. The Task Force conducts sobriety checkpoints and specific patrol details for DUI offenders.



Montgomery County Drug Task Force - The Lower Providence Township Police Department participates in the Montgomery County District Attorney's Office Local Drug Task Force to investigate drug offenses within our own jurisdiction and throughout Montgomery County. We have several police officers who are assigned to the drug task force and have been sworn in as Special County Detectives for the purpose of investigating drug offenses throughout the County.







BusPatrol

We are pleased to announce that LPPD will be working with BusPatrol and Methacton School District to reduce school bus violations from occurring and increase safety in our community. In November 2021, a press conference was held at Arcola Middle School to discuss how all Methacton School District buses will be equipped with cameras inside and outside the school bus beginning in January 2022. These cameras will be capable of capturing the illegal passing of school buses, along with other violations, and decrease bullying that may occur while students are on the bus.

According to statistics, 98% of drivers that receive a citation for their violation do not receive a second citation, which reassures us that awareness increases through this program. The fine for illegally passing a school bus is \$300.00 and that money is what helps pay for the services BusPatrol cameras provide.

Professional Standards



The Pennsylvania Chiefs of Police Association introduced the Pennsylvania Law Enforcement Accreditation Program to the Commonwealth in July 2001. Since then, 375 agencies have enrolled and 117 agencies currently have maintained accredited status.

Accreditation is a progressive and timeproven way of helping institutions evaluate and improve their overall performance. The cornerstone of this strategy lies in the promulgation of standards containing a clear objectives. statement professional of Participating administrators then conduct a thorough analysis to determine how existing operations can be adapted to meet these objectives. When the procedures are in place, a team of independent professionals are assigned to verify that all applicable successfully standards have been implemented. The process culminates with a decision by an authoritative body that the institution is worthy of accreditation.

The Lower Providence Township Police Department was accredited by the PA Law Enforcement Accreditation Commission in 2006 and has received reaccreditation every three years since that time. Accredited status The Lower Providence Township

<u>Citizen Complaints</u> - The Lower Providence Township Police Departments procedures for handling citizen complaints are consistent with national standards to assure a prompt and thorough investigation and response to all allegations. This process ensures that these issues are brought to the proper level of departmental management, and appropriately addressed to maintain a high level of integrity and instill public trust. In 2021, the department received <u>ZERO</u> formal citizen complaints against any member of the department.

<u>Commendations</u> - The Police Department received numerous letters of commendation from the public about exemplary police services. Chief Jackson awarded the department with an additional 16 letters of commendation, 12 Unit Citations, 7 Commendations of Bravery, 2 Life Saving Commendations, and 1 Commendation of Merit.

The Following Officer Received a Commendation of Merit:

On January 21, 2021, **Detective Michael Nastasi** was presented with a Commendation of Merit after being the lead investigator on a Drug Delivery Resulting in Death Investigation. Over the course of five months, Detective Nastasi meticulously and tirelessly investigated the case, which included interviews, multiple search warrants, surveillance, and an interview with the suspect. Detective Nastasi was able to obtain a confession from the suspect and he was arrested and charged with Drug Delivery Resulting in Death, Possession With Intent to Deliver a Controlled Substance, and related offenses.

The Following Officers Received Life Saving Commendations:

On February 18, 2021, **Officer Ryan Gill** was recognized and received a Life Saving Commendation for his actions involving a suicidal individual. He responded to the Arcola Bridge for a report of an intoxicated male sitting on the ledge. Upon arrival, Officer Gill immediately engaged the male in conversation and started to develop a rapport with him. After several minutes, Officer Gill was able to talk the male down from the ledge of the bridge and safely transported him to Montgomery County Emergency Services. Throughout the entire call, Officer Gill used his training and calm demeanor to save this individuals life.

On March 4, 2021, **Officer Eric Honick** was recognized and received a Life Saving Commendation for his actions involving an individual who was choking. He responded to the 300 block of South Park Avenue and when he arrived, the patient's husband was already performing the Heimlich Maneuver but was unsuccessful. Without delay, Officer Honick took over and performed the Heimlich Maneuver and was successfully able to expel the food that was lodged in the patient's throat, preventing an untimely death.









On March 2, 2021 police dispatcher, Jason Connelly, was recognized for his dedicated service to the LPPD. We sincerely appreciate all that he has done for our department and his perseverance speaks volumes. Jason was diagnosed with oral cancer in 2019 and underwent several surgeries. In the early months of 2021, he was informed that he was officially cancer free. Unfortunately, that good news lasted only a few months before it returned, and Jason continues to fight his battle with cancer. The Lower Providence Township Police Department, Lower Providence Board of Supervisors and Township Staff, Lower Providence Emergency Medical Services, and Lower Providence Fire Department showed their support for Jason by raising money to gift him a new Play Station 5 to keep his mind busy and remind him that he has a large support system rooting

for him. Additionally, the Montgomery County Hero Fund, which is an amazing corporation that provides immediate and ongoing relief to first responders as a result of a tragedy, provided Jason with a very generous donation.



Detective Nastasi's positive energy and work ethic is something to be proud of and we are pleased to name him this year's Officer of the Year! Congratulations Mike!



Youth Aid Panel Program

The Lower Providence Township Police Department participates in Montgomery County's Youth Aid Panel and referred 24 juveniles to the program in 2021.

The Youth Aid Panel (YAP) Program has been giving juveniles a second chance to have a clean criminal record since 2000. In its 20 + year history, the program has helped more than 10,000 juveniles, ages 10 to 17 (or age 18 if a current high school senior), avoid a criminal record by going before a panel of local, trained volunteers and taking responsibility for their actions. Through the involvement and support of local community volunteers and assigned interventions, the community Youth Aid Panel Program holds juveniles accountable for their actions with conditions that focus on community responsibility while facilitating positive outcomes.

The YAP Program is an alternative to having a juvenile charged with their criminal infraction and having the matter handled in Juvenile Court. Successfully completing YAP means the juvenile will not have a criminal record that can be found through background checks routinely done by colleges and employers. The program is also designed to help juvenile offenders avoid future contact with the juvenile justice system through the involvement and support of local community volunteers, who serve on the more than 40 active Youth Aid Panels across Montgomery County.

2021 Retirements

After 35 years of service, Officer Daniel McGuffin retired from the Lower Providence Township Police Department on April 30, 2021. Officer McGuffin is a 1978 graduate of Archbishop Carroll High School in Radnor, Pennsylvania. He attended Ursinus College and received his Associates Degree in Police Science in December of 1983 from Montgomery County Community College. He attended the Montgomery County Police Academy and graduated in April of 1984. He was hired as a police dispatcher with the Lower Providence Township Police on July 1, 1985 and was sworn in as a full-time police officer on September 21, 1987.

Officer McGuffin served in the Patrol Division and was assigned to the Traffic Safety Unit for many years. While in the Traffic Safety Unit he implemented several initiatives that significantly improved conditions for township residents and the motoring public within our community. In 2010, Officer McGuffin was honored and awarded with the Respect For Law Award from the Lower Providence Optimist Club.

NEW EQUIPMENT

- We have implemented several new pieces of equipment into our department this year. First, BolaWrap, which is a restraint tool developed to provide safe distance between the subject and the officer. It does not rely on pain compliance and is specifically designed to be deployed early in an engagement. The device discharges a Kevlar rope that wraps around the subject's legs or arms, preventing them from harming themselves, police, or other individuals.
- Next, we purchased a Decatur Electronics Speed Display Trailer. The display trailer shows a vehicles speed, displays various messages, and has flashing red and blue lights on it. We can move this piece of equipment around to different streets where we want to deter speeding and reckless driving.
- We also purchased six **PopShield Ballistic Armor Shields**. The shields can be deployed in less than a second by pressing the instant release trigger and then held to protect the officers head, face, arms, and torso. The shields weigh 5 pounds, they are discrete and highly maneuverable, providing three times more protection.
- Lastly, we purchased a **Stationary Automatic License Plate Reader (ALPR).** The device is installed at Egypt Road and South Trooper Road and collects data from thousands of vehicles in just a few minutes. Any wanted, known suspect, or individual driving a stolen vehicle, who drives by a stationary LPR, will send an alert to nearby police officers with the vehicle description and registration. The LPR also detects suspended/expired registration status.







PRESS RELEASE - CARDIN PLACE

On June 10, 2021, Lower Providence Township Police Officers received a 911 call from a witness advising a Lower Providence Township Code Enforcement Officer was being chased by a male with a gun. Moments later, another call came in from the Code Enforcement Officer who reported being chased by a male with a gun. The incident was initiated when the Code Enforcement Officer arrived on location to perform a follow-up inspection at the home for known hoarding conditions. After the Code Enforcement Officer entered the home, the homeowner, Thomas Razzi, displayed a firearm. The Code Enforcement Officer acted quickly and was able to exit the home and alert neighbors requesting that they contact the police.

Police Officers arrived on scene and confronted Razzi in front of his home and ordered him to stop. Razzi, who was unarmed at the time, retreated into his home, and slammed the door behind him. As additional police officers arrived on scene, a perimeter around the suspect's residence was established.

A short time later, a series of loud explosions and gunfire was heard coming from the suspect's residence. Police believed that the suspect was the source of the explosions and gunfire and that he had intentionally started the fire. At no time did police and the suspect exchange gunfire; police did not discharge their weapons. Immediately, flames and smoke became visible, and officers began evacuating nearby neighbors to a safe location. Once the scene was safe, the Lower Providence Township Fire Department responded and began fire suppression. The fire destroyed three townhomes and caused damage to three others.

The next morning, a male body found in the rubble of the suspect's home was positively identified as homeowner Thomas Razzi., 65, during an autopsy performed by the Montgomery County Coroner's Office.







HURRICANE IDA - FLOODING

Historic flooding occurred in Lower Providence Township on September 1st into September 2, 2021 due to the remnants of Hurricane Ida. Several properties were damaged and major roadways closed indefinitely due to unsafe conditions.











PRESS RELEASE - HOMICIDE

The investigation began on September 16, 2021, when Freddy Remigio Mendieta Pando walked into the Upper Darby Police headquarters and told two detectives that "I killed my partner." Mendieta Pando showed the detectives on a map, where the body could be found, which was adjacent to the Schuylkill River Trail in Lower Providence Township, near the Betzwood Trailhead. Lower Providence Police found the body of a deceased female lying face down in a wooded area approximately 15 feet off the Schuylkill River Trail. The woman was identified as Karina Torres.

The joint investigation by the Montgomery County Detectives and Lower Providence Township Police found that Torres had obtained a Protection From Abuse Order against Mendieta Pando that was in effect at the time of her murder.

On Sept. 17, 2021, Forensic Pathologist Marianne Hamel of the Montgomery County Coroner's Office performed an autopsy on the body of Karina Torres and determined that Torres died of multiple stab wounds and the manner of death was homicide.

Mendieta Pando was arrested and charged with First-Degree Murder, Third-Degree Murder and Possessing an Instrument of Crime.





LPPD is participating in a new program where our on-call detectives assist Montgomery County Detectives in their Homicide Unit. This program allows our detectives to observe and gain valuable experience, while also building relationships. Thus far, LPPD has assisted the Homicide Unit in several investigations throughout Montgomery County in 2021.



2021 Training Opportunities

Michelle trains police officers in mental health crisis intervention and de-escalation techniques. This year's training was ten hours long and consisted of classroom and practical exercises.







Law Enforcement Treatment Initiative (LETI)

The LPPD, along with the Montgomery County District Attorney's office has partnered with the Office of Attorney General's Law Enforcement Treatment Initiative (LETI). LETI seeks to reduce

criminal behavior and improve public safety by connecting those with substance use disorders to treatment and other community resources. The main goal of this program is to reduce deaths, overdoses, and crime associated with substance use disorders by getting people into appropriate programs. Individuals may present themselves to police or if the person facing arrest is eligible, police will facilitate immediate entry into treatment



through referral to the Montgomery County Office of Drug & Alcohol. Unfortunately, we are seeing more and more drug overdose deaths every year and we encourage those suffering from addiction to reach out to police for help.

The Bridge Program

Early in the year, the Lower Providence Township Police Department partnered with Montgomery County Mobile Crisis to proactively support individuals with a mental health illness or someone that may be experiencing a crisis. The Bridge Program is designed to increase connection to mental



health services for Lower Providence area residents through a quick referral mechanism. We meet on a weekly basis with a liaison from Mobile Crisis and discuss short- and long-term goals for individuals we have had contact with. Our officers are educated and trained in responding to calls involving individuals who are in crisis and this program is a wonderful resource to help aid in de-escalation and offer support.


SEPTEMBER 11TH MEMORIAL
