## LOWER PROVIDENCE TOWNSHIP SEWER AUTHORITY MINUTES OF FEBRUARY 14, 2022

The Regular Meeting of the Lower Providence Township Sewer Authority was held on Monday, February 14, 2022 at 4:30 PM in the Authority's Board Room at the Sewer Authority Office, located at 20 Parklane Drive, Eagleville, PA, pursuant to public notice and posting of time and place of said meeting.

#### **CALL TO ORDER**

The Chairman called the meeting to order at 4:30 PM and led everyone in the Pledge of Allegiance.

The Chairman stated that there was an Executive Session prior to the meeting to discuss legal issues.

#### **MINUTES**

The minutes of the January 10, 2022 meeting were presented. Upon motion of Mr. Rose seconded by Mr. Sorgini and unanimously carried, the reading of the minutes was waived and approved.

#### TREASURER'S REPORT - EXHIBIT 'A'

Mr. Sorgini presented to the Board the bills to be paid from the Revenue & Administration, Capital Improvement and Capital Reserve.

Upon motion of Mr. Sorgini seconded by Mr. Rose and unanimously carried, the Board approved payment of bills from Revenue & Administration, Capital Improvement and Capital Reserve hereto marked as Exhibit 'A'.

#### **PERSONNEL & PENSION**

#### **Employee Retirement Account**

The Chairman stated to the Board that the member assets have been transferred to Conrad Siegel by PMRS.

#### <u>457 Plan</u>

The Chairman stated to the Board that the cost for the record keeping & custodial services would be too high for the Authority to absorb for five employees for the quote received from Conrad Siegel. We are still waiting on another quote from Mission Square.

#### **EQUIPMENT & BUILDING**

Mr. McDonough reported to the Board that the rusted out spring shackles were replaced on the rear of the 2003 GMC due to the truck having failed state inspection. With this replacement we were able to get the truck inspected for the year.

#### **BUDGET & RATES**

#### PMAA Act 43

Mr. Sorgini stated to the Board that the Solicitor will look into the ramifications to the Authority and will bring back information as he finds it.

#### **CAPITAL PROJECTS**

#### 2021 Sanitary Sewer Line Replacement

Mr. Rose stated to the Board that since the last meeting the mainline pipe replacement started and completed on Second Street. Mainline pipe installation in progress within Sunnyside Avenue. Lateral installation in progress on Sunnyside Avenue.

Work anticipated during this month finish mainline pipe installation on Sunnyside Avenue. Finish lateral installation Walker Lane, Second Street and Sunnyside venue. Perform Test Pits on Alexandra Drive.

Estimate no. three in the amount of \$270,271.26 was presented for payment and will need approval for the Chairman to sign along with change order number one. The next job conference will be held in the LPTSA conference room on February 15, 2022 at 10:00 AM.

#### 2022 Sanitary Sewer Line Replacement

Design is complete and being QA/QC reviewed.

#### Exposed Sewer - Mine Run

Design is complete. The Board needs to decide if we want to include with the 2022 project or bid separately.

#### **EDU SALES**

A motion was made by Mr. Rose seconded by Mr. Sorgini and unanimously carried to approve one (1) EDU for 2600 Ridge Pike, one (1) EDU for 915 Madison Avenue and twenty eight (28) EDUs for 50 Eagleville Road.

#### **ENGINEER'S REPORT - EXHIBIT 'B'**

There were no questions on the Engineer's Report.

#### 2021 Sanitary Sewer Line Replacement

Mr. Woyden requested a motion for payment of Estimate number three and Change Order number one.

A motion was made by Mr. Rose, seconded by Mr. Sorgini and unanimously carried, to authorize the Chairman to sign Payment Estimate number three for the 2021 Sanitary Sewer Replacement Project with Anrich in the amount of \$270,271.26.

A motion was made by Mr. Rose, seconded by Mr. Sorgini and unanimously carried, to authorize the Chairman to sign Change Order number one (no cost) for the 2021 Sanitary Sewer Replacement Project with Anrich to increase substantial completion time from February 28, 2022 to July 29, 2022.

#### 2022 Sanitary Sewer Line Replacement

Mr. Rose asked the Board if they want the 2022 Projects to go out to bid in the March or wait.

After discussion, the Board agreed that they would like to be ready in March,

There were no questions on the System Superintendent's Report.

#### 139 E. Mount Kirk Avenue

Mr. Rubendall stated to the Board that while replacing the manhole at Mount Kirk Avenue and Walker Lane it was noticed that a lot of flow was coming from Mount Kirk. The main was videoed and a substantial leak was found at the house lateral at this location.

After discussion, the Board directed Mr. Rubendall to have this repaired.

#### **ATTORNEY REPORT**

Mr. Frey reported that all of his comments on legal matters had been previously discussed in Executive Session.

#### **NEW BUSINESS**

#### **Easement Ratification**

A motion was made by Mr. Rose, seconded by Mr. McDonough and unanimously carried, to ratify Mr. Walker's signature on the Temporary Construction Easement for 609 Linnett Road and a Sanitary Sewer Easement on the vacant lot on Third Street.

Adopt Pension Plan Trust Agreement - EXHIBIT 'D'

The Chairman presented to the Board the Pension Plan Trust Agreement with Mr. Rubendall to sign on behalf on the Employer and Mr. Walker to sign on behalf of the Trustee.

Upon motion of Mr. Sorgini seconded by Mr. McDonough and carried, Pension Plan Trust Agreement was approved hereto marked as Exhibit 'D'. Mr. Rose abstained from voting.

#### ADJOURNMENT

There being no further business to come before the Board, the meeting was adjourned at 5:20 PM by motion of Mr. Sorgini, seconded by Mr. McDonough and unanimously carried.

### SYSTEM SUPERINTENDENT'S REPORT FEBRUARY 2022

#### FOR WORK DONE JANUARY 1, 2022 – JANUARY 31, 2022

#### **SEWER AUTHORITY PROJECTS:**

**Construction progress meeting:** We have a progress meeting with Anrich scheduled for tomorrow at 10:00 AM at our office.

**2003 GMC:** We replaced the rusted out spring shackles on the rear of the truck due to the failing of State inspection. We took the truck back and got it inspected for the year.

**ROW:** Walked the ROW from Regency to Appledale Rd. marking manhole locations and making sure the lids are secure.

139 MT. KIRK AVE. While replacing the manhole at Mt Kirk and Walker we notice a lot of flow coming from Mt kirk. We videoed the main and found a substantial leak at the house lateral at this location.

**FOX ROAD STATION:** Deckmans got back to us with a quote for the replacement and the rebuild of the pump for. We compared the prices and gave Deckmans the ok to do the rebuild.

**CLEANED AND VIDEOED MAIN LINES:** Cleaned and videoed 2,300 foot of sewer main in various roads and ROW's.

**UPDATE - 2021 SEWER REPLACEMENT PROJECT:** Anrich is now replacing the sewer main on Sunnyside Ave. They have completed the replacement from Farmhouse Ave. to Fourth St. they also have a second crew working that replaced the sewer main on Second St. They now have two crews that have been working on lateral replacements on Walker, Second and Sunnyside.

**NO UPDATE - 609 LINNETT ROAD:** We got a quote from Anrich for the work that needs to be done on the three exposed mains on the Mine Run. It quote seems to be more than we expected so Gannett Fleming suggested that we get some other bids.

**NO UPDATE - DISLODGED MANHOLES FROM HURRICANE:** We are still in contact with FEMA trying to put in a claim in to get reimbursed for the damage done by the hurricane.

**UPDATE - OLD ARCOLA STATION SITE:** Contacted PECO and we are on the schedule to have the power disconnected for both Arcola and old Wemco pump station sites.

**NO UPDATE-WALKER STATION:** We are still waiting on a quote for pump repair and pump replacement from Deckmans.

#### PROPOSED / POSSIBLE FUTURE DEVELOPER PROJECTS:

**Providence Place:** 160 units. 61 units were allocated. 19 EDUs need to be purchased in the second phase. As of now the schedule for phase 2 is unknown.

**420 Church Road:** Possible 26 lot subdivision. Property had one house on it that was demoed. 25 EDUs may be needed

#### MAINTENANCE DEPARTMENT:

In addition to the daily inspection and maintenance of the pumping stations, the Maintenance Department:

- o Responded to 142 locations (PA One Calls).
- Routine station inspections revealed the generator battery charger at Gertrude Avenue was not
  operating. A brief investigation showed the fuse had blown. The fuse was replaced and the issue was
  resolved.
- o Replaced faulty generator block heater at St Gabes.
- o Replaced broken door closer at Valley Forge Station.
- o Snow removal at office, shop and stations.
- o Changed oil and filter and installed new battery on unit 4.
- o Locate and mark Manholes on Appledale R.O.W from regency to Appledale.
- o Video sewer main on Oakdale MH T70 to T71.
- O Video sewer main on Walker Lane MH W12 to W11.
- o Video sewer main on Ringneck R.O.W from MH Pt46 to Pt44.
- o Clean and Video sewer Main on Mockingbird MhPT17 to PT16 and PT70 to PT69 about 700'.
- o Inspect lateral repair at 4057 Cardin Place.
- o Inspect lateral repair at 2601 Woodland Ave.
- Inspect lateral repair at 617 Meadowlark Rd.
- o Inspect lateral repair at 1060 Bayless Place.
