Item #1: Hearing: *Continued from October*

Z-17-13 – **Ryan & Erika Becker, 2015 Sweetgum Lane, Collegeville PA 19426**. The applicant is requesting a variance from §143-44 to permit the construction of a two car garage addition, driveway extension, and related improvements. The parcel ID# is **43-00-12034-00-1**. Subject parcel is located on **2015 Sweetgum Lane**, and is located in the **R-1 Residential Zoning District.**
